

# "In the Wake of My Mind"

## Terms and Conditions

The VOYZX Exhibition "In the Wake of My Mind" is an independent, self-funded event. The participation fee, which varies depending on the exhibition space and services required, is destined to cover expenses such as rental of the venue, setup costs, artwork installation and dismantling services, advertising and promotional costs, publishing, and other direct and indirect costs related to the organization of the exhibition. The fee includes also storage of the unsold artworks for the period of 20 days prior the exhibition and 10 days after the exhibition. The fee not includes the packaging of the unsold artworks.

### ACCEPTANCE

Submitted applications are considered by VOYZX curatorial team on ongoing basis. Successful applicants will receive the Confirmation Letter of Acceptance.

### ARTWORKS DELIVERY

There are two options:

- a) An artist delivers artworks in person. The artworks should be delivered to the Exhibiton Hall on the first day of the installation. Artist will be notified sepatele about the date and hours.
- b) An artist ships artwork prior to the exhibition. The artworks should be delivered to the VOYZX Fine Art Project fine art storage facility no later than 10 days before the exhibition.

### LOGISTICS / CUSTOMS

Transportation and customs clearance costs are not included in the participation fee. Participating artists must provide transportation and customs clearance of their artworks at their own expense. All participating artists will receive additional information and tips with respect to shipment, customs. Our staff provides participating artists with tailored shipping options that allow to reduce their logistic costs (upon request).

### INSTALLATION

Exhibition installation and dismantling is performed by the VOYZX Fine Art Project staff. This service is included in the participation fee for simple setups. Information regarding artworks that require a complex setup needs to be submitted to the VOYZX Fine Art Project in order to evaluate their installation feasibility and cost of installation and dismantling.

### CATALOGUE

Participating artist artwork images along with relevant caption, artist's name, country of origin, and biographical profile, will be featured in the catalogue.

### ARTWORK SELLING

Due to regulations during the exhibition sales are provided by the VOYZX sales staff only. VOYZX Fine Art Project charges commission of 20% from artist's artwork(s) sales.

We encourage each participating artist to submit images of the artworks that will be at the exhibition along with the detailed information about the title, media, size, and price (in artist's local currency) no later than **September 15th, 2020**. All this information must be e-mailed to: **contact@voyzxart.com**

Please note that all prices will be converted to Canadian Dollars using the exchange rate on the date of installation.

### INSURANCE AND RESPONSIBILITY

The security with 24/7 surveillance will be provided at the fine art storage facility and at the exhibition premises. However, participating artists are advised to provide their own insurance policy covering all allowances and risks, including theft and damages of any kind - fire, water leakage, vandalism, and loss or damage of the artworks during the transportation to and from the storage facility and for the period of the exhibition. The VOYZX Fine Art Project will not be responsible for any theft or damage that may occur to the participating artists and/or their properties. The artist agrees to hold the VOYZX Fine Art Project harmless from any claim or legal action, and waives any request for compensation.

### REPRODUCTION

The VOYZX Fine Art Project reserves the right to reproduce the works on display and have them printed in advertising and other publications, as well as on the Internet and on the VOYZX Fine Art Project website.

**FEES:**

The basic participation fee is CA\$660 + GST 5% (up to 10 linear feet of walls). The price for each additional linear feet is CA\$85 + GST5%.

**PAYMENT:**

An invoice will be sent to the participant upon acceptance the application. Payment should be made within 5 days after receivig the Invoice. We accept Cash, Credit Cards, PayPal, wire and e-transfers.
